FUNCTION BOOKING TERMS & CONDITIONS

FUNCTION NUMBERS

▸ 10 – 30 GUESTS

TO CONFIRM A FUNCTION WE REQUIRE CREDIT CARD DETAILS, IF ZERO PEOPLE ATTEND THE FUNCTION \$100.00 WILL BE PROCESSED FROM YOUR CREDIT CARD

▸ 31 + 50 GUESTS

TO CONFIRM A FUNCTION WE REQUIRE CREDIT CARD DETAILS, IF ZERO PEOPLE ATTEND THE FUNCTION \$300.00 WILL BE PROCESSED FROM YOUR CREDIT CARD

▸ 51 + GUESTS

TO CONFIRM A FUNCTION WE REQUIRE CREDIT CARD DETAILS, IF ZERO PEOPLE ATTEND THE FUNCTION \$500.00 WILL BE PROCESSED FROM YOUR CREDIT CARD

MENU CONDITIONS

- EXTRA REQUIREMENTS OR EXTENSIONS CREATED DURING YOUR FUNCTION WILL BE PAYABLE AT COMPLETION OF YOUR FUNCTION, UNLESS PRIOR ARRANGEMENTS HAVE BEEN MADE.

OTHER REQUIREMENTS
